<u>Report of Scrutinizer for Voting through E-voting on Postal Ballot</u> [Pursuant to Sections 108 and 110 of the Companies Act, 2013 and Rules 20 and 22 of the Companies (Management and Administration) Rules 2014]

Scrutinizer's Report on voting through E-voting for Postal Ballot in terms of Sections 108 and 110 of the Companies Act, 2013 ("the Act") read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014

- A. Pursuant to the resolution passed by the Board of Directors of Sadhana Nitro Chem Limited (hereinafter referred as "the Company") on May 24, 2023. I, Saurabh Agarwal, Partner of M/s. MMJB & Associates LLP, Practicing Company Secretaries, have been appointed as a Scrutinizer to receive, scrutinize and process the Postal Ballot process and the votes cast in respect of the resolutions set out in the Postal Ballot Notice dated May 24, 2023 (hereinafter referred as "Notice").
- **B.** Member's approval was sought for approving the following Special Businesses by way of Ordinary Resolutions:
 - a) Issue of Bonus Shares and
 - b) Ratification of Sale/Purchase Transactions between Company and Aayan Nanotech Private Limited
- C. Pursuant to Sections 108 and 110 of the Act and Rules 20 and 22 of Companies (Management and Administration) Rules, 2014 (including any statutory modification(s) or re-enactment(s) thereof for the time being in force), Company has confirmed that the Electronic copy of the Notice and Explanatory Statement along with the process of E-voting were sent to the shareholders whose e-mail addresses are registered with the Company/Depository Participant(s)/Registrar and Share Transfer Agent of the Company for communication purposes in compliance with MCA Circular dated 5th May, 2020 read with circulars dated 8th April, 2020, 13th April, 2020, 8th December 2021 and 5th May 2022 and 28th December 2022 and SEBI Circulars dated 12th May, 2020, 28th September 2020, 15th January, 2021 and 13th May, 2022 and applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), the Secretarial Standard-2 on General Meetings issued by The Institute of Company Secretaries of India. The Company completed dispatch of Notice along with Explanatory Statement by electronic mode on Thursday, May 25, 2023 to the members whose name(s) appeared in the Register of Members/ List of beneficiaries as on Friday, May 19, 2023 ("cut-off-date").

- **D.** The remote e-voting facility was provided by National Securities Depository Limited ("NSDL").
- **E.** Members were required to communicate their assent or dissent only through remote e-voting system in terms of the said MCA Circulars.
- **F.** The e-voting period commenced on Friday, May 26, 2023 at 9.00 a.m. (IST) and ended on Sunday, June 25, 2023 at 5.00 p.m. (IST) for voting through e-voting.
- **G.** The e-voting was blocked at 5:00 p.m. (IST) on Sunday, June 25, 2023 and the e-voting summary statement was downloaded from e-voting website of NSDL.
- **H.** The Members holding shares as on the "cut off" date i.e., Friday, May 19, 2023, were entitled to vote on the proposed resolutions.
- **I.** The register, in accordance with Rule 20(4)(xiv) and Rule 22(10) of the Companies (Management and Administration) Rules, 2015, has been maintained electronically to record the assent or dissent received, mentioning the particulars of name, address, folio number or client ID of the shareholders, number of shares held by them. There were no shares with differential voting rights in the Company, hence there is no requirement of maintaining of the list of shares with differential voting rights.
- **J.** Agenda No. 2 of postal ballot is a material related party transaction as per Regulation 23 of SEBI Listing Regulation. Further, Regulation 23 (4) of SEBI Listing Regulations states that no related party shall vote to approve such resolution whether the entity is a related party to the particular transaction or not. Accordingly, we have reconciled from the list of related parties given to us by the Company and excluded their voting while finalizing the voting results.
