'Budget lacks plan for fiscal consolidation'

INDIA'S BUDGET OUTLINED some reforms that could support the economy, but its fiscal stance was left broadly unchanged with no plans for meaningful consolidation, Fitch Ratings said on Wednesday. The Budget indicates that Centre will continue its reform efforts in its second term and avoid the fiscal loosening that might have been expected given the country's sluggish growth, it said. "However, it falls short of signalling prospects for significant fiscal consolidation in the next few years. The medium-term fiscal deficit targets of 3% in FY21 and FY22 make it highly unlikely that the debt ceiling of 60% for general government debt will be met by 2024-25," Fitch said in a statement. — PTI

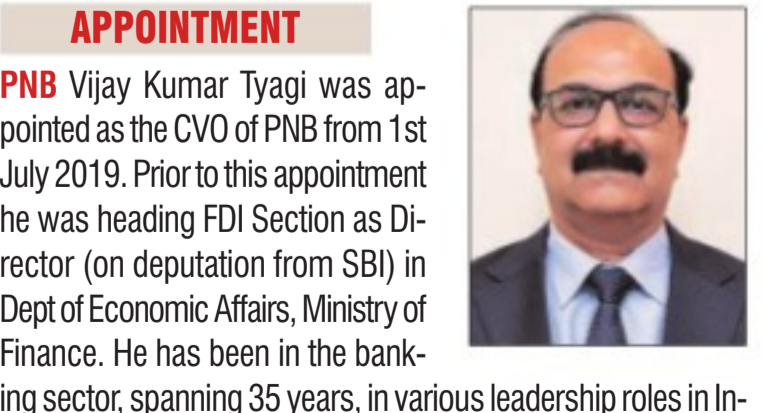
