Wheat price rise normal; have enough stocks: Govt

New Delhi, 17 October

The increase in wheat prices in the past few weeks is "normal" on account of a low base because the rates had been "artificially depressed" last year, the Centre on Monday said. It has ample stocks to intervene in the markets as and when required. "The rates fell last year because Food Corporation of India (FCI) pumped in seven million tonnes of wheat in the open market. Therefore, it is not advisable to compare the current year's increase with last year's. It should be compared with prices in 2020," Food Secretary Sudhanshu Pandey told reporters.

He said when compared with the 2020 rates, there was an 11.42 per cent increase in wholesale wheat prices at ₹27.57 per kg and 12.01 per cent in the retail wheat prices ₹31.06 per kg as on October 14 this year.

Stating that this increase was not "astronomical", Pandey said it was in tune with the hike in the minimum support price (MSP), and expenses on fuel and transportation, etc.

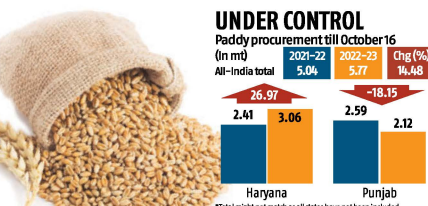
On the wheat and rice stocks in the Central pool, FCI Chairman Ashok K K Meena said the government had a wheat stock of 22.7 million tonnes, which was higher than the buffer norm of 20.5 million tonnes, till October 1.

Similarly, the rice stock was 20.5 million tonnes, higher than the norm of 10.3 million tonnes in the period concerned. The projected stocks of wheat and rice till April 1, 2023, would be much higher than the buffer norms even after the free grain supplies under the Pradhan Mantri Garib Kalyan Anna Yojana, the National Food Security Act and other welfare requirements, he added. According to FCI, the wheat stock in Central pool on April 1 next year is expected to be 11.3 million tonnes, higher than the buffer requirement of 7.5 million tonnes.

The rice stock during the same period is projected to be 23.7 million tonnes as against a buffer of 13.6 million tonnes.

Meena said the government was monitoring the prices of essential commodities and taking steps as required.

The government said paddy procurement had consistently increased since 2017 and had gone up to 88.2 million tonnes in 2021.



PM expresses concern over high import bill of edible oils

Prime Minister Narendra Modi on Monday expressed concern over India's high import bill for edible oil, fertilisers, and crude oil, and said there was a need to work in a mission mode to make the country self-reliant and reduce import dependence. With international energy prices soaring after the war in Ukraine, India will spend a record ₹2.5 billion to subsidise fertiliser for farmers. Another \$120 billion is spent on importing crude oil and the two

together are the biggest drain on exchequer.

Addressing PM Kisan Samman Smmelan 2022 event, the PM released the 12th instalment of the cash support that the government had launched ahead of the 2019 general elections, and launched a scheme to brand all subsidised fertiliser under one brand 'Bharat' to eliminate product differentiation and confusion multiple brands cause in the minds of farmers.

The amount paid to farmers (under MSP) has increased from ₹90,372.42 crore to ₹1.72 trillion in the same period. During the kharif marketing season, the projection for paddy procurement is 77.1 million tonnes and farmers are estimated to get more than ₹1.58 trillion.

Between October 1 and 16, 5.77 mil-

lion tonnes of paddy, including 3.9 million tonnes in terms of rice, has been procured, which is higher than last year.

In 2022, wheat procurement has been 18.8 million tonnes whereas requirement is 19.2 million tonnes.

Farmers, women SHGs get ₹1,866 cr

Raipur, 17 October

The Chhattisgarh government on Monday transferred more than ₹1,866 crore to farmers, agricultural labourers and members of women self-help groups (SHGs) — all beneficiaries of the state's several flagship schemes.

At a virtual function, Chief Minister Bhupesh Baghel did the transfer.

Over 2.7 million payees enrolled under the government's schemes such as the Rajiv Gandhi Naya Yojana, Rajiv Gandhi Gramin Krishi Bhumiheen Mazdoor Naya Yojana, and Godhan Naya Yojana will benefit ahead of Diwali.

Of the amount, ₹1,745 crore has been transferred to the accounts of 24 million farmers under the Rajiv Gandhi Kisan Naya Yojana. The scheme was introduced by the Bhupesh Baghel government in 2019 to provide financial assistance to paddy-growing farmers. Since inception, the state government has paid ₹16,416.10 crore, including the third instalment released on Monday, to farmers.

Chhattisgarh is the only state that has been procuring paddy from farmers at ₹2,500 per quintal, which is higher than what the Centre has set.

Besides, the state government is providing aid under the scheme to farmers adopting crop diversification and plantation.

Under the Gramin Krishi Bhumiheen Mazdoor Naya Yojana, ₹115.80 crore has been transferred to the accounts of 466,000 landless labourers.

The state government also transferred ₹5.59 crore to the beneficiaries of the Godhan Naya Yojana, the most talked-about scheme of the government. Under the scheme, *godhan* (livestock sheds) have been built in panchayats and they have become a source of livelihood for villagers.

As of now, 8,408 *gaushans* have been set up against the sanctioned 10,624 and the state government is building a rural industrial park.

SHGs have taken up projects that include manufacturing vermicompost and fertilisers from cow-dung and urine the state government is procuring under the Godhan Naya Yojana, launched in 2020.

The state government spokesperson said of the amount, ₹4.22 crore had been paid to villagers who sold cow-dung to the *Gauthan* Committee.

OIL interested in petroleum mining lease

Jaipur, 17 October

Oil India Limited (OIL) is interested in picking up a petroleum mining lease (PML) in an area spread over 67 square kilometres (sq. km) in Jaisalmer and Bikaner under the Discovered Small Field policy, a senior state government official has said.

"A proposal in this regard has been submitted to the state government and action will be taken soon," said Subodh Agarwal, additional chief secretary, mines and petroleum, Rajasthan, after meeting OIL Chairman and Managing Director Ranjeet Rath in Jaipur recently. OIL produces heavy oil and natural gas at Tanot Dandewala and Baghewala in the state, and is exploring PML for five more locations in the state.

There are four petroliferous basins in an area of 150,000 sq km in the state. Agarwal said that OIL and ONGC are producing petroleum and natural gas — they hold 11 PMLs — and under the exploration licence, Vedanta, ONGC, and OIL are doing the exploration work. The official requested OIL to begin new work in the renewable energy sector, saying there was scope in the field of solar and wind energy in the state and requested it to invest in green energy.
