- It is designed and developed in the Netherlands and built from ground up in India, this vehicle marks a significant milestone in the PCL journey as we embark on a journey to provide localized, electrified buses, trucks and LCVs to Indian customers.
- The Company has localized more than **60%** of the electric driveline in the first vehicle itself with a target to further indigenize in the upcoming vehicles.

- Hon. audience gave a patient hearing and appreciated efforts taken by Company to promote electrification of vehicles

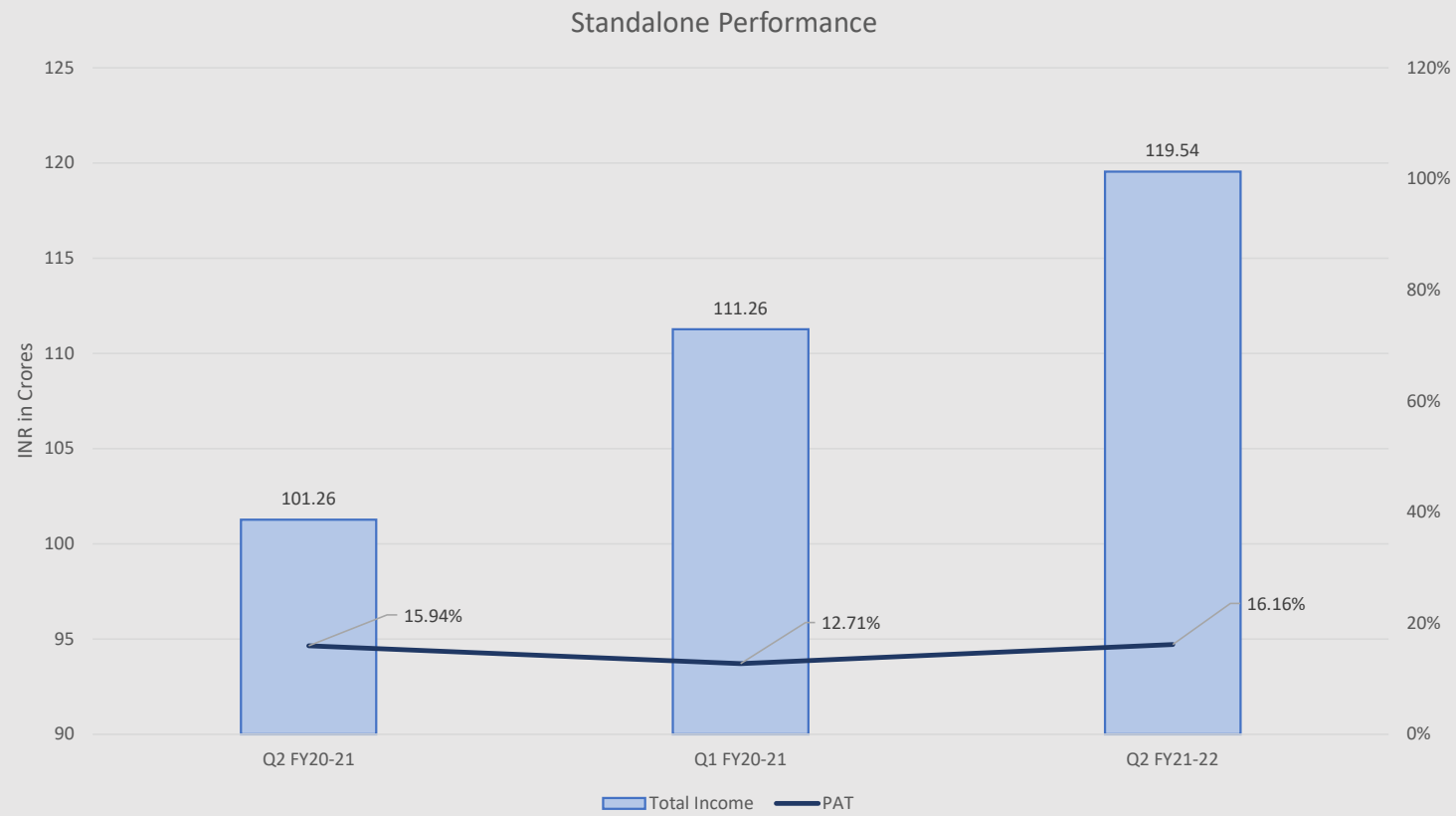


Precision Group – Signed MOU with Solapur Municipal corporation

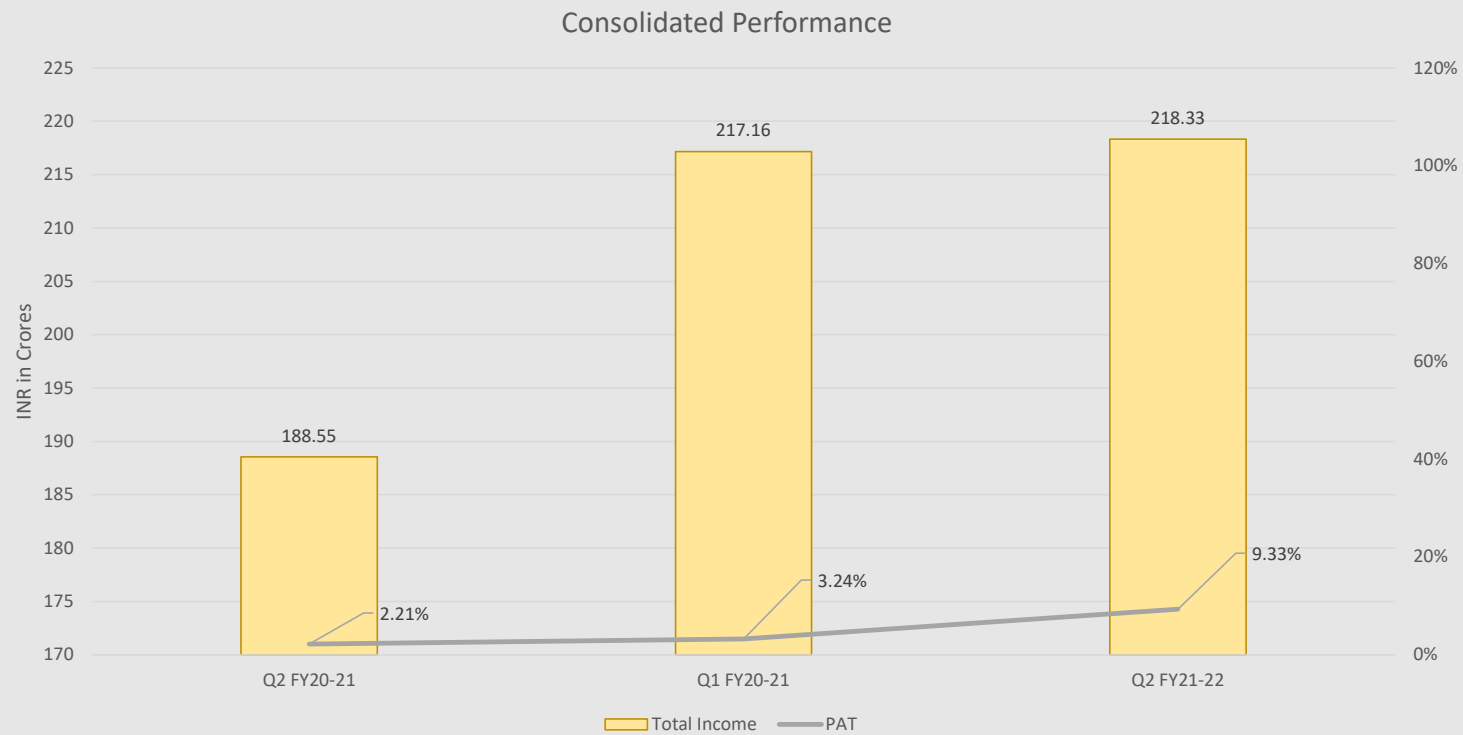
- Company signs MOU with Solapur Municipal Corporation (SMC) on 3rd November 2021

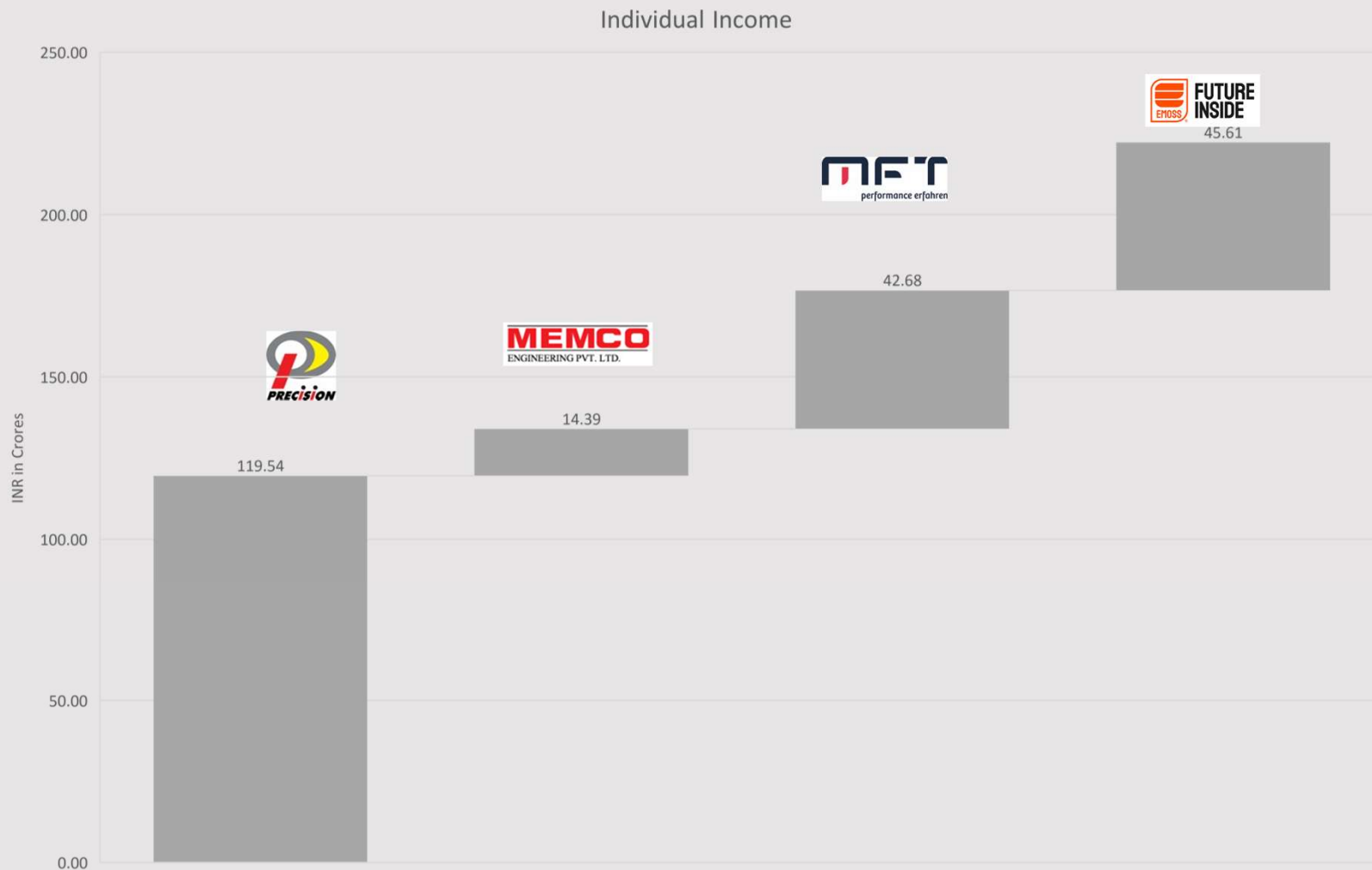
Financial Performance – Standalone



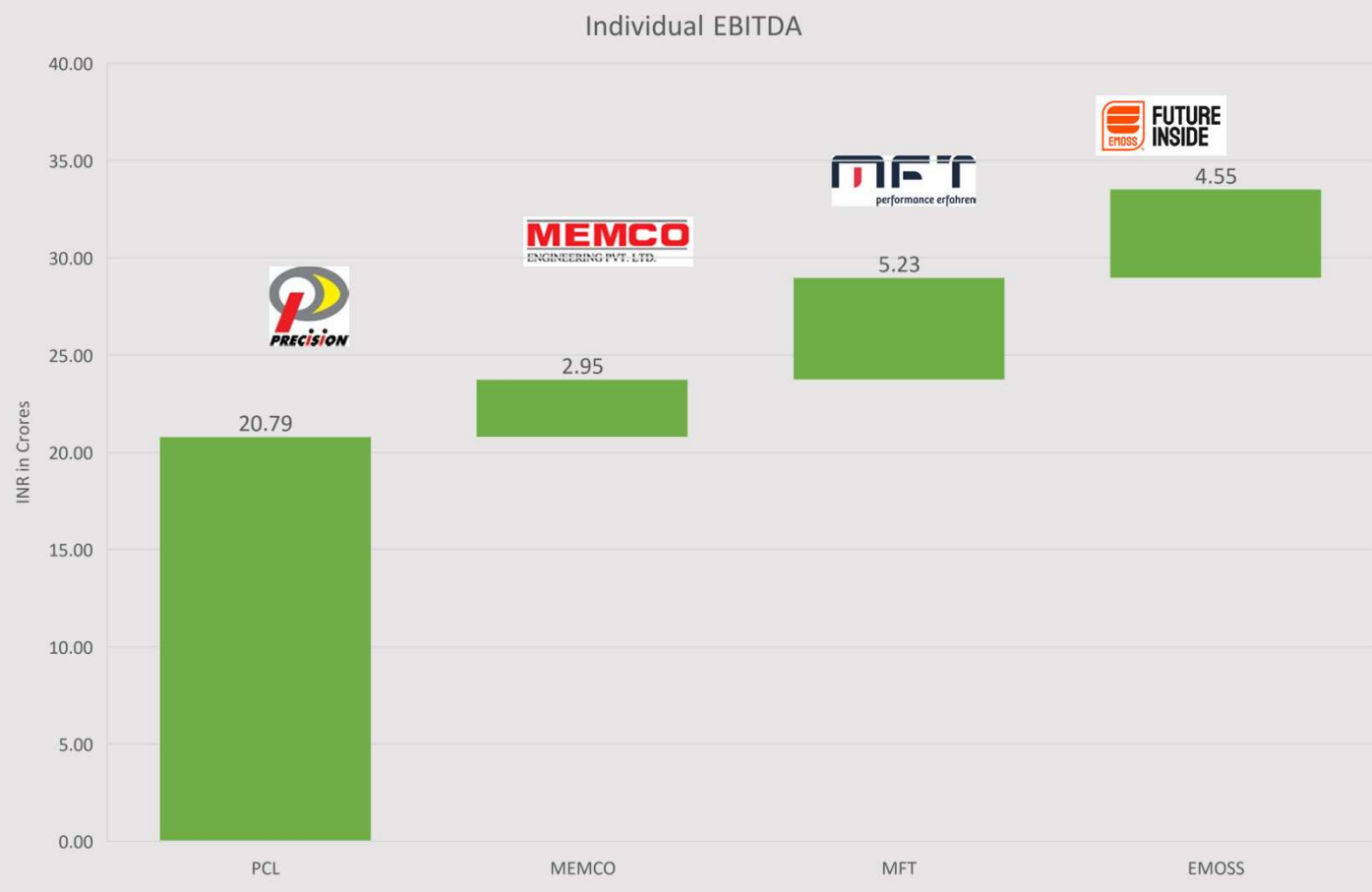
Financial Performance – Consolidated
