In the evening she searched for the ornament bag but couldn't find it. On February 3, Rathod was supposed to come for work but he did not come and hence she suspected that Rathod and the two women labourers had stolen the bag containing the gold ornaments. They had worked as labourers when the complainant had renovated her house in January this year.
