

DR SARABHAI'S STATUE VANDALISED

Bronze table, book, pen worth Rs 3 lakh stolen

EXPRESS NEWS SERVICE AHMEDABAD, OCTOBER 28

A TABLE, book and pen attached with the iconic bronze statue of Indian physicist Dr Vikram Sarabhai were stolen by unknown persons from the popular tourist site at Sabarmati Riverfront in Ahmedabad.

According to police, the bronze statue of Dr Sarabhai, sitting on a desk and writing in a notebook kept on a table, was attacked by unknown miscreants between 11 pm Tuesday to 11 am Wednesday. An FIR against unknown persons under IPC Section 379 for theft was lodged at the Sabarmati Riverfront West Police Station.

"This is not a corner of a society, this is a prime location. The statue was of Vikrambhai sitting at a desk. They've cut the desk and taken it away. Let's see what can be done," said Kartikeya Sarabhai, son of late Dr Vikram Sarabhai.

Dr Sarabhai is known as the Father of the Indian Space programme. He is also the founder of IIM Ahmedabad, the Physical Research Laboratory and ISRO's Space Application Centre.


