## Summary of the proceedings of the 7<sup>th</sup> Annual General Meeting (AGM) of the Company held on August 24, 2021

The 7<sup>th</sup> AGM of the Members of Magadh Sugar & Energy Limited ('the Company') was held on Tuesday, August, 24, 2021 at 11.00 a.m. (IST) through two-way Video Conferencing ('VC')/Other Audio-Visual Means ('OAVM') facility provided on webex platform by NSDL. The Meeting was conducted in accordance with the circulars issued by the Ministry of Corporate Affairs ('MCA') and the Securities and Exchange Board of India ('SEBI').

Mr. Chandra Shekhar Nopany, Chairperson of the Board, chaired the Meeting. The Chairman welcomed the shareholders to the Meeting and on being informed about the requisite quorum being present, called the Meeting to order. The Directors of the Company viz. Mr Raj Kumar Bagri, Chairman Audit Committee and Stakeholders Relationship Committee, Mr Padam Kumar Khaitan, Mr Ishwari Prosad Singh Roy and Mr Chandra Mohan, Wholetime Director, Mr Sudershan Bajaj, Chief Financial Officer and Mr S Subramanian, Company Secretary were present at the AGM through VC from their respective locations. The Chairman welcomed the Directors and introduced them to the Members who joined the AGM over virtual platform.

The Chairman informed the Members that, representatives of the Auditors were also present at the Meeting through VC. He then informed the Members that, the proceedings of the Meeting were also being webcast and could be viewed live by Members by logging in to NSDL website. The Company had taken the requisite steps to enable Members to participate and vote on the items being considered at this AGM. Since there was no physical attendance of Members and in compliance with the Circulars issued by the MCA and SEBI, Members were informed that the requirement of appointing proxies was not applicable. The Chairman drew the attention of members to the registers/documents made available for inspection by the members electronically.

With the consent of the Members present, the Notice convening the AGM was taken as read. Since, there was no qualification, observation or adverse remark in the Statutory and Secretarial Auditor's Reports the Auditors' Report for the year ended 31<sup>st</sup> March, 2021 were taken as read.

Thereafter, the Chairman delivered his speech. He apprised the members about the challenges posed by COVID 19 pandemic, performance of the Company for the Financial Year ended 31<sup>st</sup> March, 2021 and Corporate Social Responsibility initiatives/programs of the Company and also about its future outlook.

The Chairman informed the Members that in compliance with the provisions of Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and the provisions of Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Company had extended e-voting facility to the Members of the Company in respect of business transacted at the 7<sup>th</sup> AGM to cast their vote electronically from a place other that the venue of the Meeting, wherein the e-voting period commenced on Saturday, August 21, 2021 (9:00 AM) and ended on Monday, August 23, 2021 (5:00 PM). The Chairman further informed the Members that the facility for e-voting has been made available at the meeting for the Members who have not casted their vote through remote e-voting during the continuance of the AGM and upto 15 minutes post conclusion of the AGM.
