- 1) The Unaudited financial results for the quarter ended September 30, 2018 have been reviewed by the Audit and Risk Management Committee and approved by the Board of Directors at its meeting held on November 14, 2018. The Statutory Auditors of the Company have carried out limited review of the above financial results and have expressed an unqualified opinion. The information presented above is extracted from Unaudited standalone financial statements.
- 2) The above finanical results have been prepared in accordance with Indian Accounting Standards (Ind AS) as prescribed under section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and the Companies (Indian Accounting Standards) Rules, 2016.
- 3) The Company has only one segment namely pharmaceuticals and hence, no separate segmentwise disclosure has been made.
- 4) The Government of India introduced the Goods and Services Tax (GST) with effect from July 1 2017 which replaces excise duty and other indirect taxes. As per Ind AS, sales for the quarter and six months ended September 30, 2018, quarter ended June 30, 2018 and September 30, 2017 are reported net of GST. The year ended March 31, 2018 and six months ended September 30, 2017 includes excise duty upto June 30, 2017.

5) Figures for the corresponding previous year/period have been regrouped/rearranged, wherever necessary to make them comparable.
