**FINANCIAL RESULTS OF NLCIL FOR THE QUARTER AND
NINE MONTHS ENDED 31-12-2019**

The total income of the Company during the quarter and nine months ended 31-12-2019 was Rs.2436.75 crore and Rs.6558.63 crore respectively as against Rs.2070.29 crore and Rs.5792.47 crore in the corresponding period of the previous year, registering a growth in total income of 17.70% and 13.23% respectively in both the periods.

Profit after tax for the quarter and nine months ended 31-12-2019 was Rs.361.55 crore and Rs.1021.37 crore respectively as against Rs.329.49 crore and Rs.976.84 crore in the corresponding period of the previous year, registering a growth of 9.73% and 4.56% respectively in both the periods.

Power generation during the quarter and nine months ended 31-12-2019 was 5469.47 MU and 15801.60 MU as against 5430.79 MU and 15087.34 MU in the corresponding period of the previous year, registering a growth of 0.71% and 4.73 % respectively in both the periods.

The EBIDTA for the quarter ended 31-12-2019 was Rs.1089.74 crore as against Rs.751.21 crore, registering a growth of 45.06%. The EBIDTA for nine months ended 31-12-2019 was Rs.2752.95 crore as against Rs.2203.04 crore, registering a growth of 24.96%.

During the period, Company successfully commissioned 351 MW Solar Power Plant bringing the total installed capacity of Solar Power Plants of the Company to 1.35 GW and also successfully commissioned one unit of 500 MW Lignite based 1000 MW (2 X 500 MW) Power Plant which is first of its kind in the country.
