Shah said, "(In 2017) just three years after departure of Narendrabhai (to Centre as Prime Minister), voters were in doubt (how will the government work in his absence). Now, voters have

understood that Narendrabhai (Modi) has created such an arrangement that government will work just like the one under him even if he is not there.'
