# Details of murder and evidence: Aaftab quizzed in polygraph test

DURING HIS 6-7-hour polygraph test on Thursday, Aaftab Poonawala, who is accused of murdering his live-in partner Shraddha Walkar, was asked if and how he committed the crime, where he hid the evidence and questions about his childhood and family, among other things.

Earlier in the day, police sources said they had recovered almost 10-12 "sharp objects", including knives, blades, saws and other tools, from the couple's Chattarpur Pahadi flat and the Mehrauli forest over the past week. Continuing their search for evidence in other states, a Delhi police team in Mumbai's Vasai trawled through a creek in Bhayandar to search for Walkar's phone, which they suspect was destroyed by Poonawala.

Poonawala was taken to the Forensic Science Lab (FSL) in Delhi's Rohini for the first session of the polygraph test around noon and left with police around 8 pm. Sagarpreet Hooda, Special CP (Law and Order), confirmed

but we take breaks so the person does not feel anxious or pressured," said an officer.

Police had earlier taken Poonawala for pre-analysis questioning but had to delay the exercise after he complained of fever. Earlier this week, police had sought permission from a Delhi court to extend Poonawala's custody and conduct polygraph and narco-analysis tests on him. The narco test will most likely be conducted next week, said police.

On the sharp objects recovered, a police officer said: "We are checking them for blood traces. Poonawala had said he used two-three mini-saws to chop Walkar's

body into 30-35 pieces in the bathroom. We haven't been able to find the exact weaponry yet... We are verifying his claims."

A team of Delhi Police also went to Thane in Maharashtra to conduct searches. "As he came to Mumbai after Walkar's death, he may have dumped her belongings and other evidence in Vasai or Thane," said an officer. Delhi Police said they also recorded Poonawala's father's statement. As per Walkar's family and friends, Poonawala's family allegedly knew about the violent fights between the couple, said police. "His father said he doesn't know anything about the murder. He said Poonawala would rarely talk to them. We are trying to get details on their relationship and Poonawala's behaviour," added the officer.

On the search for Walkar's phone in Mumbai, a police source said: "Poonawala claimed he disposed of her SIM card in Delhi and threw her phone in the creek at Bhayandar. We have learnt he had come back from Delhi to help his parents shift to a new place from Vasai to Mira Road. While crossing the creek in the train, he is believed to have thrown the phone into it."

## Agencies acting in tandem, Vijay Nair tells HC

*New Delhi:* The Delhi High Court Thursday sought responses from AAP communications manager Vijay Nair and Hyderabad-based businessman Abhishek Boinpally in a CBI plea challenging bail granted to them by a trial court, related to alleged irregularities in the now-scrapped excise policy case.

A single judge bench of Justice Yogesh Khanna deferred the hearing of applications for stay of the trial court order after noting that Nair and Boinpally were already in custody of Enforcement Directorate in connection with an alleged money laundering probe into the excise policy.

Appearing for the CBI, special public prosecutor Nikhil Goel submitted: "Our case is that at instance of (Nair), large sums of money came to Delhi. We have evidence to show Rs 30 crore of cash was received... we have to investigate what happened to the cash and the person who paid, what does he gain?"

Appearing for Nair, senior advocate Rebecca John said the agency can get "as many statements of witnesses to say (Nair) influenced the policy. But there are layers of checks and balances... soon as this bail order was passed, I was arrested (by ED). This is how agencies act in tandem". ENS

## In Faridabad, suitcase with body parts found

*Gurgaon:* A suitcase with suspected body parts inside was found in a forest area in Faridabad's Surajkund Thursday afternoon, said police.

"It appears to be a torso. It seems the limbs, head and other parts had been decapitated. The remains are decomposed... Prima facie, it appears a person was murdered elsewhere and a part of the body was dumped here to avoid identification. The remains had been wrapped in a plastic bag and a sack. Two-three clothes and a belt were recovered near the suitcase. The entire forest area within the vicinity has been cordoned off and searched. Forensic teams are collecting samples, which will be sent for identification and DNA analysis," said a police officer.

Sube Singh, spokesperson, Faridabad police, said, "No identification has been done. The remains have been sent to civil hospital for the autopsy. We are checking CCTV in the vicinity."

Police sources confirmed they had contacted the Delhi Police team investigating the Shraddha Walkar case. "We had contacted Delhi Police officers in Mehrauli to also look at the remains, but no association with the case in Delhi has emerged so far," said a police officer. ENS
