We would like to inform you that Disclosures of the Related Party Transaction on a consolidated basis under Regulation 23(9) of SEBI (Listing Obligations and Disclosure Requirements) (Amendment) Regulations, 2018 is not applicable to our Company and the certificate of Non Applicability of Regulation 23(9) of SEBI(LODR) regulation (Amendment) Regulations, 2018 has already submitted to Stock Exchange on 31<sup>ST</sup> May, 2023 as per Annexure – I enclosed for your reference. There are no option available in XBRL for non applicability of Related Party Transactions.

Further, we would like to clarify that our claiming exemption under Regulation 15(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the compliance with the corporate governance provisions as specified in regulations 17, 17A,18, 19, 20, 21,22, 23, 24, 24A, 25, 26, 27 and clauses (b) to (i) 41[and (t)] of sub-regulation (2) of regulation 46 and para C , D and E of Schedule V shall not apply, in respect of listed entity having paid up equity share capital not exceeding rupees ten crore and net worth not exceeding rupees twenty five crore, as on the last day of the previous financial year.

Accordingly, the Company is not required to submit the Related Party Transaction disclosures as required under regulation 23(9) of SEBI (LODR), Regulations, 2015 as the paid up equity share capital of the Company is Rs. 308.94 Lakhs - and the Net worth of the Company is Rs. 507.42 Lakhs as on 31st March. 2023. Hence it is not applicable to the Company.

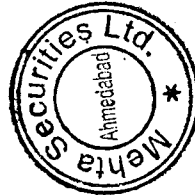
