## ● Satellite city: Blend of 2 districts, 2 civic bodies and 2 talukas Residents get scratching heads: One Navi Mumbai, 3 lockdowns

AMIT SRIVASTAVA / Navi Mumbai  
Most parts of Navi Mumbai are currently under strict lockdown, except for nodes where there is none. This has created confusion residents, as they face a double whammy - stiff action from both police and the local authority even if they accidentally enter a lockdown area. Social media is flooded with messages from those seeking clarity on which parts of the city are under lockdown.

Police, as well as local bodies, are taking action against those found crossing over from one node to another without an urgent reason



While Navi Mumbai Municipal Corporation (NMMC) falls under the Thane district, the Panvel Municipal Corporation (PMC) comes under the Raigad district. Meanwhile, the Uran and Panvel Gramam taluka are also part of Navi Mumbai city but fall under the Raigad district.

There are a number of developing nodes in Navi Mumbai which do not fall either in NMMC or PMC, but in Raigad district. NMMC and PMC had already announced a lockdown for 10 days which ended on July 13. NMMC extended the lockdown for a week till July 19. The Raigad district had earlier declared a four-day lockdown in Uran taluka. Now, it has announced a complete lockdown across the district for 10 days from July 14.

Since the PMC, Uran taluka and Panvel Gramam fall under the Raigad district, there will be a lockdown for 10 days. Interestingly, the jurisdiction of NMMC is from Airoli to Belapur and the lockdown period is till July 19. Even after the lockdown in NMMC area ends on July 19, citizens from NMMC's jurisdiction cannot go to even Kharghar, Ulve or Uran as there will be a lockdown till July 24. Similarly, when NMMC and PMC had declared lockdown for 10 days, there was no lockdown in Uran and Panvel Gramam taluka. Developing nodes like Ulve, Vichumbe and Karanjde had no lockdown. However, in order to travel among these nodes, people have to cross NMMC and PMC jurisdiction where there was lockdown.

## Dy mayor of MBMC is all for unlocking economy

The BJP-led ruling governance in the Mira Bhayandar Municipal Corporation (MBMC) has impressed upon the civic chief the need to resume economic activities by gradually easing the total lockdown which has been imposed in the twin-cities. After a brief stint of getting into unlock mode, newly appointed municipal commissioner Dr Vijay Rathod had imposed a 10-day total lockdown from July 1 which has now been extended till the

midnight of July 18. In his letter to the civic administration, "Instead of imposing closure of establishments, we should focus on relaxation" - Dy Mayor Hasmukh Gehlot deputy mayor Hasmukh Gehlot has sought implementation of Mission Begin Again instead of lockdowns which were not the only solution to fight the pandemic. "We are already into an economic mess, people will end up losing

their jobs and livelihood due to prolonged lockdowns. Instead of imposing closure of establishments, our focus should be on relaxations albeit with a proper mechanism in place to keep a tab on violations to ensure that all rules including maintaining social distancing are being religiously followed," said Gehlot. Congress corporator Sarah Akram echoed similar views while demanding an end to lockdown extensions henceforth.

## Cops book 5726 Covidiot in 10 days

In a bid to strictly enforce lockdown measures, the Thane (rural) police have once again started cracking the whip against Covidiot (defiant law-breakers in a pandemic situation) in the twin-cities. Since the imposition of the 10-day total lockdown, the traffic department has registered 5,726 cases under the relevant sections of the Motor Vehicle Act and netted fines amounting Rs 23.72 lakh from violators. "With 4,447 cases, bikers topped the list for violations like double seat and helmetless riding followed by erring auto-rickshaws

and other private vehicles for ferrying more passengers while flouting mandated physical distancing norms. The lockdown has been extended till July 18 and the drive will continue," said Senior Police Inspector (Traffic) Shekhar Dombhe. On the other hand, 145 cases of lockdown violations and action against 608 people for venturing out without any valid reasons were registered at local police stations in the twin-cities. Nearly 290 vehicles were also impounded. The Kashmirira police topped the list with 41 cases, several cases of bootlegging and ferrying illicit liquor have been registered

against the hooch mafia. "It is the duty of all to behave responsibly to prevent the spread of the disease. Please stay home, venture only if it's unavoidable and cooperate with the police and district administration," appealed SP Dr. Shivaji Rathod. In the first phase of relaxation from the lockdown to contain the spread of Covid-19 pandemic, bikers cannot ride with pillion even as rickshaws have been allowed to ply with only two passengers, to ensure physical distancing. Despite an alarming rise in the number of positive cases, some people have continued to defy the lockdown.
