I, Kaushal Dalal, Proprietor of M/s. - a. - d. The Company has appointed KFin Technologies Limited (Previously Known as KFin Technologies Private Limited ("KFin") ("RTA") for conducting the Remote e-voting by the members of the Company.
- e. The Remote e-Voting commenced on Friday, May 06, 2022 at 9:00 am IST and ended on Saturday, June 04, 2022 at 5.00 pm IST.
- f. Pursuant to the provisions of the Act and MCA Circulars, the Company has sent Postal Ballot Notice dated April 28, 2022, to its Members whose names appeared in the Register of Members/Register of Beneficial owners maintained by the Depositories, as on the Cut-off date i.e. April 29, 2022 and whose email addresses were registered with the Company, KFin, Depositories or the depositories participant(s), through electronic means only and has not dispatched physical notices to any member. Further the Company vide the Postal Ballot Notice dated April 28, 2022, had also requested its members to register their email addresses with the RTA / Depository Participant(s), as the case may be.
- g. As stated in Sub-rule 3 of Rule 22 of Companies (Management and Administration) Rules, 2014, as amended, advertisements were published by the Company in 'Free Press Journal' & 'Navshakti' on editions of Friday, May 06, 2022, informing the Members about the completion of dispatch of Postal Ballot Notice, to the Members entitled along with other related matters mentioned therein.
- h. Due to COVID-19 pandemic and nationwide lockdown announced by the Central/State Government, physical Ballot was not dispatched and provisions of MCA Circulars were adhered. Therefore, neither the Company nor I have received any physical copy of documents related to stated Postal Ballot.
- After completion of remote e-voting, the Result thereof was unblocked from the website of Kfin i.e <u>www.evoting.kfintech.com</u> in the presence of my authorised representative who was not in the employment of the Company.
- The particulars of report downloaded from the website of Kfin have been entered in a separate register maintained for the purpose of Postal Ballot.
- k. The Votes cast by Corporate/ Institutional Members who have emailed the scanned certified true copy of the Board Resolution / Authority Letter, etc. at email ID: <u>kaushaldalalcs@gmail.com</u> or have uploaded on the website of Kfin have been considered valid.
- The Postal Ballot and other related documents/registers and record will be handed over to the Company Secretary for the safe custody once the Chairman considers, approves and signs the Postal Ballot Minutes.
