Mr. Mahesh Bhave, Company Secretary:

Good Afternoon all the shareholders and Directors of KSB Limited.

I, Mahesh Bhave, Company Secretary, welcome you all to the 61st Annual General Meeting of KSB Limited.

All the shareholders joining this meeting, are by default placed on mute mode, to avoid any background disturbance and to ensure smooth and seamless conduct of the meeting.

I now request Mr. Gaurav Swarup, Chairman who is joining from Kolkata, to take charge of the meeting.

Mr. G. Swarup, Chairman:

Good Afternoon and a warm welcome to all shareholders and Directors to the 61st Annual General Meeting. The meeting is being conducted through video conference mode in accordance with the Companies Act, 2013, MCA Circulars and SEBI circulars.

As the requisite quorum is present, I call the meeting to Order.

We have with us, Mr. Milind Khadilkar, Chief Financial Officer - Joined from Pune.

I would like to express my gratitude to the Board of Directors of KSB Limited for their leadership, strategic guidance and valuable contributions which shaped a better performance during the year 2020. I would like to put on record and thank each member of the Board for their support and participation during such situations. The Board has been fully and effectively functional during these times.

Representatives of the Statutory Auditors M/s Price Waterhouse Chartered Accountants, have joined from Pune.

Representative of the Secretarial Auditors M/s Nilesh Shah and Associates, Company Secretaries, has joined from Mumbai.

Since this AGM is being held electronically, physical attendance of the shareholders has been dispensed with and also the requirement of appointing proxy is not applicable.

The prescribed Statutory Registers are open for inspection by the shareholders during the meeting, on the website of the Company.

As the Notice of the AGM is already circulated to all the shareholders, with your permission, I take the Notice of the meeting as read.

Further, as the report of the Statutory Auditors was unqualified and without any adverse observations or comments, with your permission I take the Auditors' Report as read.

As we meet during these unprecedented times, we are happy to share that this year the KSB Group is celebrating its 150th anniversary. The KSB Group has successfully achieved various milestones in this extensive journey of 150 years and our Company is a proud member of this Group. The KSB Group has strived hard to deliver its best in all these years of commitments and will continue to do so in future; and so does KSB Limited.

May I now share the highlights of the Company's performance for the year ended, 31st December, 2020.

As we all know, the Financial year 2020 was challenging due to adverse situations of COVID-19 pandemic. The Company's plants across locations were shut during the lockdown towards the end of the first quarter of 2020 and thus the turnover was marginally impacted. The plants resumed the operations following the government protocols and the extensive focus was on health and safety of employees at each site.

Despite such multi-pronged challenges the Company could achieve relatively good performance during the year 2020. The Company could achieve higher profitability as compared to previous year due to:

- i. reduction in fixed costs and overheads in the face of pandemic situations;
- ii. due to excellent steps taken by management for cost cutting measures, and
- iii. timely execution of orders and improving productivity.

The order-intake in 2020 was 10% lower as compared to 2019. Exports were at nearly the same level.

Water and Waste Water sectors performed well during 2020 and showed growth over 2019. Energy Sector showed growth mainly on account of very good order booking for FGD pumps. Despite a complete lock down for 2 months in the first half of 2020, the Agricultural business picked up in the last 2 quarters and the Order Intake in this sector was nearly at the same level as 2019.

Supreme Serve business also performed well during 2020.

Some major orders received by the company in 2020 were:

- Tata Projects for NTPC Talcher and NTPC Vallur – Value INR 418 Mio
- Thermax for DVC Koderma and Tata Power Maithan – Value INR 108 Mio
- L&T Hydrocarbon Engineering for HPCL Vizag RUF project – Value INR 500 Mio

The company continued the use of technology to stay connected – whether to enable working from home or to virtually engage with customers and other stakeholders.

The business operations of the subsidiary, Pofran Sales and Agency Limited have been stopped subsequent to termination of agency agreement with M/s Schroedahl.

The Associate Company, KSB MIL Controls Limited has earned a profit before tax of INR 147 Million for the year 2020.

Despite the ongoing business environment, the Board has recommended dividend of 85% in its Board Meeting held on 25th February, 2021 for approval of the shareholders,

As per the notice of the 61st AGM, the Nomination and Remuneration Committee of the Company and the Board have recommended the re-appointment of Mr. Rajeev Jain as Managing Director for 5 years from 1st July 2021. I request the shareholders to consider and approve the business as proposed in the Notice.

As per the notice of the 61st AGM, I request the shareholders to consider and approve all the businesses as proposed in the Notice.

Dear Shareholders, once again, KSB Limited team has performed well in 2020 despite the challenging times. On behalf of the Board of Directors, I express my sincere appreciation for the efforts and hard work from employees at all levels, and wish them all the best in their efforts for the success of the Company in this year.

Before concluding, may I, at the instance of the Board of Directors, acknowledge with appreciation, the guidance, support and encouragement from KSB Group. I also thank to the Company's bankers, the other lending institutions, and all the shareholders.

In the end, I would like to re-iterate that we are very optimistic about the Company's future and believe that, despite of the Covid 19 pandemic, our Company will continue to prosper. We remain confident that the current business impact is temporary.

I thank you all for participating in this meeting.

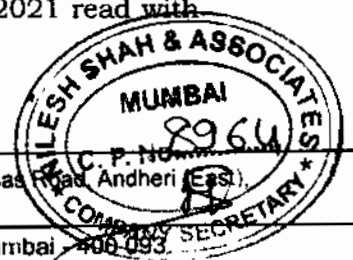

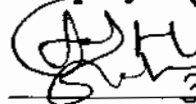
In this regard, I hereby submit my report as under:

- 7 The result of the voting through remote e-voting and e-voting during AGM processes is as per annexure attached herewith.

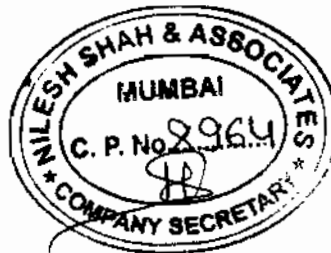
