- (iii) Date and time of end of "Remote e-voting" : Thursday, 28th September, 2023 at 5:00 P.M.(same day)
- (iv) Cut-off date for E-Voting : Friday, 22nd day of September, 2023
- (v) Remote E-voting shall not be allowed beyond 5:00 P.M. on Thursday , 28th September, 2023.
- (vi) Any person, who acquires shares of the Company and become member of the Company after dispatch of the notice and holding shares as of the cut-off date i.e. 22nd day of September, 2023, may obtain the login ID and password by sending a request at evoting@nsdl.co.in or ho@agiopaper.co.in. However, if you are already registered with NSDL for remote e-voting then you can use your existing user ID and password for casting your vote. - (vii) The members who have casted their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.
