
In accordance with SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information in terms of Regulation 8 of SEBI (Prohibition of Insider Trading) Regulations, 2015, we would like to intimate the following:

- 1) The Bank's advances aggregated to approximately ₹ 9,340 billion as of December 31, 2019, a growth of around 20% as compared to ₹ 7,810 billion as of December 31, 2018 (₹ 8,970 billion as of September 30, 2019).
- 2) The Bank's deposits aggregated to approximately ₹ 10,675 billion as of December 31, 2019, a growth of around 25% as compared to ₹ 8,525 billion as of December 31, 2018 (₹ 10,216 billion as of September 30, 2019).
- 3) The Bank's CASA ratio stood at around 39.5% as of December 31, 2019, as compared to 40.7% as of December 31, 2018 and 39.3 % as of September 30, 2019.
- 4) During the quarter ended December 31, 2019, the Bank purchased loans aggregating ₹ 42.58 billion through the direct assignment route under the home loan arrangement with Housing Development Finance Corporation Limited.

The above information is subject to a limited review by the statutory auditors of the Bank. We request you to bring the above to the notice of all concerned.
