Ride service Didi told to take app off stores

Beijing: Ride-hailing service Didi Global Inc., which made its US stock market debut last week, was ordered by Chinese regulators to remove its app from online stores while the company overhauls its handling of customer data. Dozens of e-commerce firms have been told to handle customer information more carefully as the Communist Party tightens control over their influential industries. A probe found violations in how Didi collected and used personal information, the Cyberspace Administration of China announced. A statement said the firm was told to 'rectify problems' but gave no details. Didi said it would 'strictly comply' but gave no details. A statement on its social media account said customers who downloaded the Didi app before Sunday's order can keep using it normally. AP
