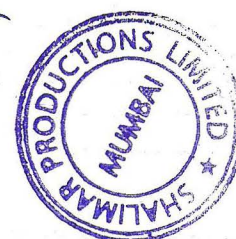

**LIMITED REVIEW REPORT TO SHALIMAR PRODUCTIONS LIMITED**

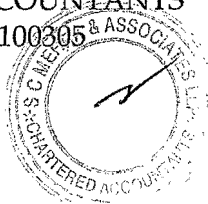
