- **4.** Subject to approval of the members of the Company the Board of Directors has declared dividend of Rs. 1/- (Rupees One only) per share i.e @10% on equity share of face value of Rs. 10/- (Rupees Ten only) each, fully paid up, for the financial year ended on 31 March 2020
- 5. Re-appointment of M/s. Grant Thornton India LLP as the Internal Auditor of the Company for the Financial Year 2020-2021 pursuant to Section 138 of the Companies Act, 2013.
