- 1. The above standalone financial results of the Company were reviewed and recommended by the audit committee on 7th Aug 2020 and subsequently approved by the Board of Directors at its meeting held on the 7th Aug 2020. The review report has been filed with stock exchange and is available on the Company's website.
- 2. The above financial results have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) as amended, prescribed under Section 133 of the Companies Act, 2013, read with relevant rules issued thereunder.
- 3. The financial results for the quarter ended 30th June 2020 have been subjected to limited review by the statutory auditors of the Company. The statutory auditor has issued an unqualified review opinion on the financial results.
- 4. The Company has migrated to the main board of Bombay Stock Exchange w.e.f. 27th May 2020, accordingly the Company had not prepared financial results for the previous quarters. However comparative figures of quarter ended 30th June 2019 and 31st March 2020 as given above have been prepared by the management after exercising necessary due diligence to ensure financial results reflects true and fair view of Company's affairs.
- 5. Financial results for the quarter ended 30th June 2019 & 31st March 2020 were neither audited nor subjected to limited review report by auditors.
- 6. The Company is engaged in the business of Injection Moulding and Blow Moulding plastic articles such as Industrial containers, Healthcare furniture, and automotive components. There is no separate reportable segment in terms of IND AS-108 and hence there is no requirement of segment reporting.
- There are no investor complaints pending as on 30TH June 2020.
- 8. The Company continues to consider the impact of COVID-19 pandemic in assessing the recoverability of receivables, goodwill, intangible assets, and certain investments. For this purpose, the Company considered internal and external sources of information up to the date of approval of these financial results. The Company based on its judgements and estimates expects to fully recover the carrying amount of trade receivables, investments, and other financial assets. The impact of COVID-19 remains uncertain and may be different from what we have estimated as of the date of approval of these standalone financial results and the Company will continue to closely monitor any material changes to future economic conditions.
- 9. Previous periods' figures have been regrouped / reclassified where required to make them compatible with the figures of current periods.
