#### PROCEEDINGS OF 72ND THE ANNUAL GENERAL MEETING OF THE COMPANY

- The 72<sup>nd</sup> Annual General Meeting ('**AGM**') of Kokuyo Camlin Limited ('**the Company**') was held on Thursday, 8<sup>th</sup> August, 2019 at 3:00 p.m. at Walchand Hirachand Hall, Indian Merchant Chamber Building, Indian Merchants Chamber Marg, Churchgate, Mumbai 400 020.
- Mr. Dilip D. Dandekar, Chairman of the Company chaired the meeting and introduced all the Directors present on the Dias.
- All the Board of Directors except Mr. Devendra Kumar Arora and Mr. Hisamaro Garugu, Chief Executive Officer, Chief Financial Officer, Company Secretary, Statutory Auditor and Secretarial Auditor were also present at the meeting. The Chairman after ascertaining the quorum, declared the meeting to be in order.
- The Chairman informed the members about proxies/representations received by the Company and the necessary registers/records which were available for inspection for the members present.
- With the consent of the members present, the Notice convening the 72<sup>nd</sup> AGM forming part of the Annual Report and the Auditors' Report being without any qualification, was taken as read.
- Thereafter, the Chairman informed the members that pursuant to the provisions of the Companies Act, 2013 and the rules thereunder the Company had provided to all members the facility of remote e-voting and voting through ballot, to vote on the resolutions contained in the notice of the AGM. The e-voting process was open between 5th August, 2019 to 7th August, 2019 and Mr. J.H. Ranade, Practicing Company Secretary of M/s. JHR & Associates was appointed as the scrutinizer to carry out the e-voting and ballot process.

The Chairman also informed the members that the Company has arranged for voting by poll to those members who had not already cast their vote by remote evoting or ballot process.

The Chairman further informed that the results of voting shall be declared within forty eight hours from the conclusion of this meeting.
