INDIAN NAVAL Ship Shardul set sail from the port of Bandar Abbas in Iran carrying 233 stranded Indians to Porbandar in Gujarat on Monday, official sources said. "There are about 233 pas-

sengers. Most of them are fish-ermen from Valsad who have been staying in small hamlets and working there," defence sources told The Indian Express. The evacuation is part of Operation Samudra Setu. Officials said that the naval

Officials said that the navar ship is expected to reach Porbandar by Thursday. After disembarkation at Porbandar, the evacuated people will be en-trusted to the care of state authorities.

"The video was brought to our notice today and we have identified eight of them. There are around 10 others in the

video and the process to identify them is under way. The incident happened in the evening and since the relaxations were given till 9 pm in the night, they did not get caught," said Jaydeepsinh Jadeja.
