# Active Covid cases in country decline to 84,931, inoculation coverage crosses 211.9-cr mark



New Delhi With 7,591 new coronavirus infections being reported in the last 24 hours, India's total tally of Covid-19 cases rose to 4,44,15,723, while the active cases declined to 84,931, according to the Union Health Ministry data updated on Monday.
