- (b) the filings/ submissions made by the listed entity to the National Stock Exchange of India Limited (NSE) and BSE Limited (BSE), where its equity shares are listed ('the stock exchanges'),
- (c) website of the listed entity; and
- (d) other relevant documents/filings which have been relied upon to make this certification,

for the financial year ended 31st March 2022 ('review period') in respect of compliance with the provisions of:

- (a) the Securities and Exchange Board of India Act, 1992 ('SEBI Act') and the Regulations, circulars, guidelines issued thereunder; and
- (b) the Securities Contracts (Regulation) Act, 1956 ('SCRA'), rules made thereunder and the Regulations, circulars, guidelines issued thereunder by the Securities and Exchange Board of India ('SEBI').
- B. The **Specific Regulations**, whose provisions and the circulars/ guidelines issued thereunder, have been examined, are:

 - (i) The Securities and Exchange Board of India (Depositories and Participants) Regulations, 2018.
- C. Based on the above examination and the information, explanations and representations provided to us by the listed entity, its officers, agents (including Share Transfer Agent) and authorised representatives during such examination, we hereby report that, during the review period:

- (a) The listed entity has complied with the provisions of the above Regulations and circulars/guidelines issued thereunder.
- (b) The listed entity has maintained proper records (by itself or through the Share Transfer Agent) under the provisions of the above Regulations and circulars/ guidelines issued thereunder insofar as it appears from our examination of those records.
- (c) No action has been taken against the listed entity, its promoters or directors, either by SEBI or by NSE/BSE (including under the Standard Operating Procedures issued by SEBI through various circulars) under the aforesaid Acts/ Regulations and circulars/guidelines issued thereunder.

 - (iv) Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018.
- (f) The terms of appointment of the Statutory Auditors of the listed entity are in compliance with the provisions of Para 6(A) and Para 6(B) of SEBI Circular CIR/CFD/CMD1/114/2019 dated October 18, 2019. The listed entity does not have any material subsidiaries.
