Dear Sir,

Pursuant to Regulation 30 of (SEBI Listing Regulations, 2015) read with SEBI Circular No. CIR/CFD/CMD1/114/2019 dated October 18, 2019, we wish to inform that based on the recommendation of the Audit Committee, the Board of Directors of the Company at its meeting held on October 26, 2021 noted and accepted the resignation of M/s. B. M. Parekh & Co., Chartered Accountants (Firm Registration number: 107448W) who have tendered their resignation vide their letter dated October 25, 2021 informing their pre-occupation and also on account of advance age which has limited ability to work and keep self-updated with the change in law, unable to continue as the Statutory Auditors of the Company. The Audit Committee noted that statutory auditors have not raised any concern or issue and there is no other reason other than as mentioned in the resignation letter.

The Board of Directors at its meeting held today i.e. October 26<sup>th</sup>, 2021 also noted that there is no other reason other than as mentioned in the resignation letter.

Further, the Board of Directors at their meeting held on October 26, 2021, on the recommendation of the Audit Committee, subject to approval of shareholders, has approved the appointment of M/s. Agarwal Desai & Shah as Statutory Auditors of the Company to fill the casual vacancy caused due to the resignation from M/s. B. M. Parekh & Co, as Statutory Auditors of the Company, till the conclusion of ensuing Annual General Meeting of the company. The Board has recommended the same for the approval of shareholders at the ensuing General Meeting. The said appointment is pursuant to applicable provisions of the



Companies Act 2013 and the SEBI Listing Regulations, 2015. M/s. Agarwal Desai & shah, Chartered Accountants (Registration no. 124850W) have confirmed their eligibility for appointment.

Details with respect to resignation/ change in Auditors of the Company as required under Regulation 30 Read with Schedule III of the Listing Regulations, SEBI Circular CIR/CFD/CMD/4/2015 dated September 09, 2015 and CIR/CFD/CMD1/114/2019 dated October 18, 2019 are annexed herewith.
