

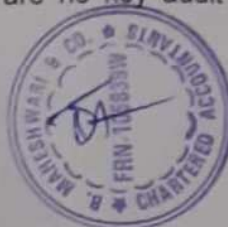
Basis for Opinion
