i. **Re-appointment of Independent Directors:** Upon the recommendations of Nomination and Remuneration Committee of the Board ("NRC"), the Board recommended the re-appointment of Mr. Anuj Puri (DIN: 00048386), Mr. Dilip Cherian (DIN: 00322763), Mr. Shashidhar Narain Sinha (DIN: 00953796), Mr. Jayant Davar (DIN: 00100801) and Mr. Ravi Sardana (DIN: 06938773) as Independent Directors (whose current tenure will end at the ensuing 43rd Annual General Meeting to be held in the calendar year 2019 ("the AGM")) to the Board of the Company, for a second term of 5 (five) years, to be approved by the shareholders in the AGM through special resolution.

Cessation of term of Independent Directors: Ms. Anita Nayyar (DIN: 03317861), Independent Woman Director of the Company, whose second and final term of 3 (three) years is completing at the AGM, and Mr. Rajendra Kumar Jhunjhunwala (DIN: 00073943), Independent Director, whose first term of 5 (five) years is completing at the AGM. Mr. Jhunjhunwala has conveyed to the Board that due to personal reasons he does not seek re-appointment for a second term.
