Please note that the Fund Raise Committee of the Board of Directors of the Company, at its meeting held today i.e. Tuesday, October 04, 2022, has, approved allotment of 6,896,097 Equity Shares of face value ₹ 10 each to eligible qualified institutional buyers at the issue price of ₹ 725 per Equity Share, i.e., at a premium of ₹ 715 per Equity Share, (which includes a discount of ₹ 37.88 (4.97% of the floor price) to the floor price), aggregating to approximately ₹ 5000 million, pursuant to the Issue.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up equity share capital of the Company stands increased from ₹ 1,002,871,990 consisting of 100,287,199 Equity Shares to ₹ 1,071,832,960 consisting of 107,183,296 Equity Shares.

The QIP opened on September 28, 2022 and closed on October 03, 2022 and the same was intimated to you through our letters dated September 28, 2022 and October 03, 2022, respectively.
