दिल्ली में चार साल की बच्ची के अपहरण, यौन उत्पीड़न के मामले में एक व्यक्ति गिरफ्तार

नई दिल्ली, (वीअ)। राष्ट्रीय राजधानी के भलस्वा डेयरी इलाके में चार साल की बच्ची का कथित रूप से अपहरण कर उसका यौन उत्पीडन करने के आरोप में 40 वर्षीय एक व्यक्ति को गिरफ्तार किया गया है। पुलिस ने मंगलवार को यह जानकारी दी। उन्होंने बताया कि बच्ची गत बुधवार की शाम अपने घर के बाहर खेलते समय लापता हो गई थी। उसके माता-पिता ने भलस्वा डेयरी थाने में इसकी शिकायत की और फिर भारतीय दंड संहिता की धारा 363 (अपहरण की सजा) के तहत मामला दर्ज किया गया।

पुलिस अधिकारियों ने बताया कि अगले दिन सुबह करीब सात बजे बच्ची एक पार्क के पास मिली। उसे अस्पताल ले जाया गया, जहां चिकित्सकों ने उसका यौन उत्पीडन होने की पृष्टि की। उन्होंने बताया कि इसके बाद यौन अपराधों से बच्चों का संरक्षण (पॉक्सो) अधिनियम के प्रावधानों सहित अन्य प्रासंगिक धाराओं को प्राथमिकी में जोड़ा गया। वहीं सोशल मीडिया पर प्रसारित एक वीडियो में आरोपी को बच्ची को कहीं ले जाते हुए देखा जा सकता है। पुलिस उपायुक्त (बाहरी उत्तर क्षेत्र) देवेश कुमार महला ने बताया कि मामले में अनिल पाठक नाम के व्यक्ति को भलस्वा डेयरी इलाके से गिरफ्तार किया गया है। उन्होंने

बताया कि पुलिस को सूचना मिली थी कि पाठक को इलाके में देखा गया है और इससे पहले कि पुलिस की टीम वहां पहुंचती, स्थानीय लोगों ने उसे पहचान लिया और उसकी पिटाई कर दी। पुलिस के एक वरिष्ठ अधिकारी के मुताबिक, आरोपी ने दावा किया है कि वह दिल्ली से बाहर था, और उसके दावों की जांच की जा रही है।

पुलिस ने बताया कि दिहाड़ी मजदूर पाठक भलस्वी डेयरी इलाके में अपनी पत्नी और बच्चों के साथ रहता था। उन्होंने बताया कि मामले की जांच के लिए 10 दलों का गठन किया गया है। दिल्ली महिला आयोग (डीसीडब्ल्यू) ने शहर की पुलिस को नोटिस जारी कर इस घटना पर की गई कार्वाई की

अदालत ने जबरन वसूली के आरोपी को दी जमानत, कहा जमानत नियम है

नई दिल्ली. (वीअ) दिल्ली की एक अदालत ने जबरन वसली के एक मामले में एक आरोपी को जमानत प्रदान करते हुए कहा कि मामले के गुणदोष को सजा मानकर जमानत देने से इनकार नहीं किया जा सकता। विशेष न्यायाधीश शैलेंद्र मलिक ने आरोपी अनुज श्रीवास्तव को राहत दी, जिस पर 85 वर्षीय बुजुर्ग को बलात्कार के झूठे मामले में फंसाने की धमकी देकर उनसे जबरन वसूली करने का आरोप है।

न्यायाधीश ने 30,000 रुपये के निजी मुचलके और इतनी ही राशि के एक मुचलके पर जमानत अर्जी को स्वीकार कर लिया। न्यायाधीश ने उसे अदालत की पूर्व अनुमति के बिना देश नहीं छोड़ने और गवाहों को प्रभावित या संपर्क नहीं करने या सबूतों के साथ छेड़छाड़ नहीं करने का निर्देश दिया।

उन्होंने कहा, दलीलों पर विचार करने और इस तथ्य पर ध्यान देने के बाद कि अभियुक्ताआवेदक पिछले तीन महीनों से न्यायिक हिरासत में है तथा अधिक जांच की जरूरत नहीं है। कानुन में स्थापित सिद्धांत है कि (मामले में) गुणदोष को सजा मानकर जमानत से इनकार नहीं किया जा सकता है जबिक जमानत नियम है और इससे इनकार अपवाद है। अभियोजन पक्ष के मामले मुताबिक, आरोपी ने बुजुर्ग को धमका कर चार लाख रुपये अपने खाते में डलवा लिए। शिकायतकर्ता के अनुसार, उन्हें अगस्त 2022 में उनके व्हाट्सएप पर आपत्तिजनक तस्वीरें और वीडियो मिले, साथ ही पैसे देने की मांग की गई थी, ऐसा नहीं करने पर उन्हें झुठे मामले में फंसाने की धमकी दी गई। अभियोजन ने जमानत का विरोध किया है।
