SUBJECT: EXTENSION OF LAST DATE OF FIRST AND FINAL CALL PAYMENT PERIOD BY ONE DAY i.e., 20TH OCTOBER, 2021.

FIRST AND FINAL CALL PAYMENT PERIOD ON 5,55,330 PARTLY PAID-UP EQUITY SHARES OF FACE VALUE OF INR 5 EACH ISSUED AND ALLOTTED ON RIGHTS BASIS, PURSUANT TO LETTER OF OFFER DATED 17TH OCTOBER, 2020 ("FIRST AND FINAL CALL PAYMENT PERIOD")

We refer to our intimation dated 1st October, 2021 wherein, the First and Final Call Payment Period of Fifteen days starting from Tuesday, 5th October, 2021 and ending on Tuesday, 19th October, 2021 (both days inclusive) was fixed.
