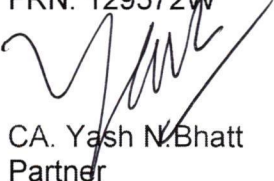
In view of the above, we express our inability to continue as the statutory auditors of the Company and therefore are submitting our resignation with immediate effect.
