The accident was reported to the Joint Director of Industrial Safety and Health (DISH), Coimbatore. Company paid full salary to the injured contract worker for the days he was absent to work and reimbursed all the medical expenses incurred by him at the hospital. Necessary corrective action was also taken at the accident site.</p> <p>The Company received summons' from the Chief Judicial Magistrate, Coimbatore, to which the Company's representative appeared for the hearings. At the final hearing on March 11, 2024, the Chief Judicial Magistrate imposed a fine of Rs. 30,000 on the Company. The fine was paid by the Company on March 11, 2024, as directed by the Chief Judicial Magistrate but a written and certified order to that effect was not made available on that day. The original copy of the Court Order was received today, 25-4-24, through the Company's Attorney.</p>
