Sub.: TDS Certificate in respect of tax deducted at source from interim dividend payment - FY 2021-22

As you are aware, Navin Fluorine International Limited ("the Company") has paid interim dividend to all its shareholders on and from November 15, 2021 upon its declaration by the Board of Directors of the Company at its meeting held on Tuesday, October 19, 2021.

Pursuant to the Income-tax Act, 1961, as amended by the Finance Act, 2020, the Company has deducted tax at source (TDS), at the prevailing rates, while making payment of the above dividend only in respect of those shareholders whose dividend income exceeded the threshold limit during the Financial Year and where no valid exemption form was provided. Pursuant to this, the Company has deducted TDS from the interim dividend payment made to you. The Company is required to furnish the requisite certificate for TDS in Form No. 16A. Accordingly, the necessary certificate in respect of the TDS is being provided at the link in this communication.
