

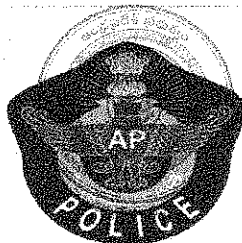


So kindly Let me know the present status of my Folio shares and procedure for applying for a duplicate Share Certificate of the same.
