*In term of Section 48 and 55 of the Companies Act, 2013 shareholders of the Company through postal ballot result dated 20.09.2017 passed a resolution wherein they have extended tenure of redemption of 10\% 41,50,000 Redeemable Cumulative Preference Shares (NCRPS) by a further period of 15 years subject to redemption of $10 \%$ every year from 21st year onwards i.e with effect from 30th October, 2023 till 30 th October, 2032.

However, one of the shareholders along with other shareholders, acting in concern with it, objected to the said extension of redemption period and filed a petition before the Hon'ble NCLT New Delhi Bench, challenging the aforementioned shareholder's resolution. Vide order dated 24.11.2017 the Hon'ble NCLT Delhi was pleased to stay the aforementioned shareholder resolution's effect till further order. The matter has been dismissed for non-prosecution.
