STOCK EXCHANGE ARBITRATION MECHANISM

Sebi SOP for dispute resolution

PRESS TRUST OF INDIA New Delhi, May 31

CAPITAL MARKETS REGULATOR Sebi has come out with a new standard operating procedure (SOP) for dispute resolution under the stock exchange arbitration mechanism, for disputes between a listed issuer and its shareholders.



With the stock exchange where the initial complaint has been addressed. The new framework will

come into force with effect from June 1, the Securities and Exchange Board of India (Sebi) said in a circular on Monday.

The new SOP will be applicable to listed issuers or RTAs offering services on behalf of listed firms in case of claims or disputes arising between the shareholder or investor of listed firms and the RTAs, the RTAs will be subject to the stock exchange arbitration mechanism.
