

Opinion

1. We have audited the accompanying annual Standalone financial results ("the Statement") of **SOLID STONE COMPANY LIMITED ("the Company")** for the year ended 31 March 2024 ("Statement"), attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015) as amended ("Listing Regulations")
2. In our opinion and to the best of our information and according to the explanations given to us, the aforesaid standalone annual financial results:
 - i. are presented in accordance with the requirements of Regulation 33 the Listing Regulations in this regard; and
 - ii. gives true and fair view in conformity with the applicable accounting standards and other accounting principles generally accepted in India, of the net profit and other comprehensive income and other financial information of the Company for the year ended 31 March, 2024.

Basis of Opinion
