EXPLANATORY STATEMENT

Pursuant to Section 102 of the Companies Act, 2013 ("Act")

Item No. 1

Based on the recommendations of Nomination and Remuneration Committee, the Board of Directors at its meeting held 18th August 2017, had appointed Mr. Raman Singh Sidhu as an independent director of the Company for the first term of consecutive period of 5 years from 18 August 2017 up to 17 August 2022. His appointment was also approved by the shareholders at Thirty First Annual general meeting of the Company held on 12 July 2018.

Since the first term as independent director is due to expire on 17 August 2022, based on the recommendations of the Nomination

and Remuneration Committee, considering the skills, experience & knowledge he possesses and the report of performance evaluation for the financial year 2021-22, the Board at its meeting held on 30 June 2022 recommended the approval of the members, the re-appointment of Mr. Raman Singh Sidhu for a second term of five consecutive years with effect from 18 August 2022 upto 17 August 2027 in terms of section 149 read with Schedule IV to the Act and Listing Regulations or any amendment thereto or modification thereof.

In accordance with section 149(10) of the Act, an independent director shall hold office for a term up to five consecutive years on the Board of a Company, but shall be eligible for re-appointment for a further period of 5 years on passing of a special resolution by the Company and disclosure of such appointment shall be made in the Board's Report. Mr. Raman Singh Sidhu fulfils the requirement of an independent director as laid down under section 149(6) of the Act and regulation 16 of the Listing Regulations.

In respect of the said appointment, a notice in writing in the prescribedmanner as required by section 160 of the Act, as amended and rules made thereunder, has been received by the Company, regarding his candidature for the office of the director.

Mr. Raman Singh Sidhu has given his consent for the said re-appointment and has also submitted the declaration of independence, as required pursuant to section 149(7) of the Act, stating that he meets the criteria of independence as provided in section 149(6) and regulation 16 of the Listing Regulations and is not disqualified from being appointed as a director in terms of section 164 of the Act.
