Dear Sir,

I, CS Debasis Dixit (Company Secretary in Practice) has been appointed as Scrutinizer by the Board of Directors of LT Foods Limited (the Company) in its meeting held on 31st January, 2022, pursuant to Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for the purpose of scrutinizing Remote e-voting in a fair and transparent manner and for ascertaining the requisite majority for passing the resolutions as contained in the aforementioned Notice and reproduced herein below:

Ordinary Resolutions:

- 1. Approval of Material Related Party Transactions with Daawat Foods Limited for the Financial Year 2022-23
- 2. Approval of Material Related Party Transactions of the Subsidiaries of LT Foods Limited with LT Foods Americas Inc (Wholly Owned Subsidiary of LT Foods Limited) for the Financial Year 2022-23

The Board of Directors of the Company issued the Postal Ballot Notice dated 31st January, 2021 (Hereinafter referred as "Notice") and decided to provide to the members of the Company, facility to exercise their voting right on the resolutions as set out in the notice by way of voting through electronic means ('e-voting") only; as required under the provisions of Section 108 and 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 read with General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 22/2020 dated June 15, 2020, General Circular No. 33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020, General Circular number 10/2021 dated June 23, 2021 and General Circular number 20/2021 dated December 8, 2021 issued by the Ministry of Corporate Affairs ("MCA") (hereinafter collectively referred to as "MCA Circulars").

I hereby submit my report on the voting on the Ordinary Resolutionsas proposed in the Postal Ballot Notice dated 31st January 2022 as under:-

1. The Compliance with the provisions of the Companies Act, 2013 and the Rules made there under relating to e-voting by the shareholders on the resolutions contained in the Notice of the Postal Ballot of the Company is the responsibility of the Management. Our responsibility as a Scrutinizer is to ensure that the voting process through electronic means is conducted in a fair and transparent manner and render Scrutinizer's report of the total votes cast in favour or against if any, to the Chairman on the Resolutions, based on the reports generated from the electronic voting system provided by National Securities Depository Limited (NSDL).



- 2. In terms of applicable provisions of the Companies Act, 2013 read with rules madethereunder MCA Circulars, company has made arrangement with NSDL for providing facility/platform for Remote e-voting.
- 3. As confirmed by Management, the Postal Ballot Notice dated 31st January, 2022 was sent electronically on 2nd March, 2022to the members who had registered their Email IDs with the Depository Participants/Depositories. As exempted under MCA Circulars, hard copy of Postal Ballot Notice along with Postal Ballot Forms and pre-paid business reply envelope were not sent to the Members for the present Postal Ballot.
- 4. As required under Rule 22(3) of Companies (Management and Administration) Rules, 2014, the Company has published an advertisement on 3rd March, 2022 in Financial Express (English News Paper-All Edition) & Jansatta (Hindi Newspaper-Delhi Edition).
- 5. As per Companies (Management and Administration) Rules, 2014 as amended upto date, the remote evoting opened from 2nd March, 2022 at 09:00 AM and ended on 31st March, 2022 at 05:00 P.M.
- 6. The Equity Shareholders holding shares as on 18th February 2022, "cut-off date", were entitled to vote on the Resolutions stated in the Notice dated 31st January, 2022 of Postal Ballot of the Company.
- 7. After the closure of Voting period on 31st March, 2022, I have unblocked the electronic votes in the presence of two witnesses, who are not the employees of the Company and the e-voting results/ list of equity shareholders who have voted for and against were downloaded from the e-voting website of National Securities Depository Limited (NSDL) (https://www.evoting.nsdl.com).
