## Ref: Rejection of Issuance of duplicate share certificates

With reference to your undated letter Ref. No. RTA/JP/PHY/IOL/2019 received by us, kindly note as under:

- 1) Regarding request for filing FIR, please find attached a confirmation of complaint lodged for the lost share certificates on the Mumbai Police website. We have been informed that we can only file a complaint and not an FIR because the certificates are lost, not stolen.
- 2) Please find the indemnity bond's signed by two independent sureties (Rajesh Ramniklal Shah residing in Borivli West and Rajesh Babulal Shah residing in Kandivali West. Witnesses and sureties are different now.
- 3) We have attested self attested PAN cards and residence proofs of both shareholders, witnesses and sureties.

If you now raise any additional grounds for refusal which have not been raised before, this would clearly indicate your intention to delay providing the share certificates for unknown reasons. In such circumstances, we shall be constrained to file a complaint against you as well as the company on the SEBI SCORES platform as harassment of small shareholders.
