In the light of the prevailing uncertainty across the country created by the second wave of COVID19 pandemic, please find the following updates as on today regarding impact of business of the Company.

- 1.The Company has done reasonable business in the first half of April 2021 on the partial lock down in some key geographies in the second half of the month for slow down pace.
2. The Company's all factories in Chengalpattu District is continuing normal operations by strictly adhering all the relevant COVID protocols and guidelines announces by Tamil Nadu State Government.
3. Lockdown/partial lockdown announced by some of the State Governments including Maharashtra, Delhi, Rajasthan, Chhattisgarh, Karanataka, Orissa and TamilNadu are severely affected the operations.
4. The impacts of the business due to this are significant as of now. While there are challenges with reference to logistics/movements of goods, the Company has sufficient level of finished goods/inventories to take care of the demand.
5. The Company's various offices at Chennai and Chengalpattu District are working with minimum strength and rest of the employees have been advised to work from home.
