Sub: <u>Intimation of Acquisition - under Regulation 30 read with Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015</u>

We refer to our letter dated 6th July, 2021 read with letter dated 28th December, 2021 ("Annexure 1"), informing that the Company had entered into a Share Subscription and Shareholders' Agreement ("SSSHA") with ReNew Sunlight Energy Private Limited ("RSEPL"), an Associate of the Company and ReNew Green Energy Solutions Private Limited ("RGESPL") for subscribing to 1,60,74,000 Equity Shares of RSEPL, in one or more tranches, which would result in the Company holding upto 31.2% of the Equity Share Capital of RSEPL by 31st March, 2022.

In this connection, we would like to update you that, the Company, RSEPL and RGESPL have today entered into a Supplemental Share Subscription and Shareholders' Agreement ('Supplemental SSSSHA').

Pursuant to the Supplemental SSSSHA and owing to availability of a higher debt financing to RSEPL, the Company's percentage shareholding in the Equity Share Capital of RSEPL would increase from the existing 31.2% to 37.2%. There would be no change in the total number of Equity Shares of RSEPL agreed to be subscribed by the Company.

The Company has today subscribed to the balance 80,37,000 Equity Shares of Rs. 10/- each of RSEPL at par for a consideration of Rs.8.04 crores and the Company's percentage shareholding in the Equity Share Capital of RSEPL has increased to 37.2%.

The details as required under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. CIR/CFD/CMD/ 4/2015 dated 9^{th} September, 2015 have already been disclosed in the letter dated 6^{th} July, 2021 which is enclosed.
