**Sub: Allotment of Shares under Company Employee Stock Option Schemes**

The Allotment Committee of the Board of Directors of the Company at its Meeting held today, has approved an allotment of 21,018 equity shares of Rs.10/- each, being the exercise of 8,343 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013), 9,675 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014) and 3,000 equity stock options under the Employee Stock Option Scheme, 2022 (ESOS 2022).

The Company shall apply for the listing and trading permission shortly.
