New BJP prez likely to be in office by Jan '25

NEW DELHI

The new president of the Bharatiya Janata Party will be elected following close consultations between Prime Minister Narendra Modi and the ideological mentor of the party, the Rashtriya Swayamsewak Sangh. The BJP is at the moment on a "correction course" with respect to the RSS, who it had antagonised with the comments of the incumbent president J.P. Nadda ahead of the Lok Sabha elections.

Nadda's statement that the BJP was no longer dependent on the RSS for fighting elections -- as it was now "Saksham" (capable), as opposed to earlier when it was "aksham" (incapable) - had not gone down well with the organisation cadre and they had largely stayed away from actively campaigning for the party, leading to a sharp decline in its Lok Sabha tally. However, since then the BJP had made amends and pacified the RSS through a slew of step – including getting the ban removed on government servants joining it.

The party is this time also expected to have a person with RSS background as its president. The process for selection of the next president was set rolling last month with the announcement of the name of K. Laxman, the national president of BJP's OBC Morcha, as the national returning officer.

Irfan Ansari & Sita Soren locked in intense contest

Jamtara, a notorious hub for online fraud, is set to witness a keen electoral battle between Congress candidate and minister Irfan Ansari and BJP candidate Sita Soren, daughter-in-law of JMM founder Shibu Soren.

Jamtara is scheduled to poll in the second phase of Jharkhand assembly election, scheduled on November 20. The first phase of assembly election was held on Wednesday witnessing an estimated voter turnout of 66.48 percent. Results will be declared on November 23.

In the run up to the poll, Jamtara constituency witnessed an unusual face-off between Congress and JMM candidates and Sita Soren, wife of Shibu Soren's eldest son Durga Soren who passed away in $\overline{2009}$.

Ansari allegedly referred to Sita Soren and called her a "rejected" and a "borrowed" player, soon after he filed his nomination papers. His remark virtually triggered a political row as even his apology failed to move her and her new party.

Sita broke down as she spoke before the media about the remarks made by Irfan. She contended the tribal community would never forgive him and accused him of making such comments as her husband was no more.

Bomb in Indigo flight, proved hoax call, passenger arrested

A Kolkata bound indigo flight having 187 passengers on board was forced to make an emergency landing at the Raipur airport on Thursday morning after one of the passengers intimated the crew member about presence of live "bomb" on the aircraft, officials said.

After landing at the airport in capital city Raipur, the aeroplane was thoroughly checked by a joint security force team including CISF, Raipur police, bomb defusing squad, but nothing suspicious was found in the flight. After the bomb threat was found as a hoax call, police lodged a complaint against the passenger under the provisions of Aviation Act 1992 and by arresting him sent to jail.

The flight 6E-812, with 187 passengers and six crew members on board, landed at the Swami Vivekananda Airport in Raipur sometime after 9 am following the passenger's claim about the bomb in the plane Raipur SSP Santosh Singh told media.

After full sanitation the bomb in the flight concluded into a hoax call and finally police arrested the passenger, the SSP said. The accused was identified as Animesh Mandal, resident of Nagpur.

New BJP prez likely to be in office by Jan '25

NEW DELHI

The new president of the Bharatiya Janata Party will be elected following close consultations between Prime Minister Narendra Modi and the ideological mentor of the party, the Rashtriya Swayamsewak Sangh. The BJP is at the moment on a "correction course" with respect to the RSS, who it had antagonised with the comments of the incumbent president J.P. Nadda ahead of the Lok Sabha elections.

Nadda's statement that the BJP was no longer dependent on the RSS for fighting elections -- as it was now "Saksham" (capable), as opposed to earlier when it was "aksham" (incapable) - had not gone down well with the organisation cadre and they had largely stayed away from actively campaigning for the party, leading to a sharp decline in its Lok Sabha tally. However, since then the BJP had made amends and pacified the RSS through a slew of step – including getting the ban removed on government servants joining it.

The party is this time also expected to have a person with RSS background as its president. The process for selection of the next president was set rolling last month with the announcement of the name of K. Laxman, the national president of BJP's OBC Morcha, as the national returning officer.

Irfan Ansari & Sita Soren locked in intense contest

Jamtara, a notorious hub for online fraud, is set to witness a keen electoral battle between Congress candidate and minister Irfan Ansari and BJP candidate Sita Soren, daughter-in-law of JMM founder Shibu Soren.

Jamtara is scheduled to poll in the second phase of Jharkhand assembly election, scheduled on November 20. The first phase of assembly election was held on Wednesday witnessing an estimated voter turnout of 66.48 percent. Results will be declared on November 23.

In the run up to the poll, Jamtara constituency witnessed an unusual face-off between Congress and JMM candidates and Sita Soren, wife of Shibu Soren's eldest son Durga Soren who passed away in $\overline{2009}$.

Ansari allegedly referred to Sita Soren and called her a "rejected" and a "borrowed" player, soon after he filed his nomination papers. His remark virtually triggered a political row as even his apology failed to move her and her new party.

Sita broke down as she spoke before the media about the remarks made by Irfan. She contended the tribal community would never forgive him and accused him of making such comments as her husband was no more.

Irfan Ansari was born on 17 January 1975 in Deoghar, Jharkhand. He studied at AN College, Patna. Later in 2000, he did his MD from Ukraine. He is a doctor by profession. In the 2014 assembly elections, he defeated BJP's Birendra Mandal by a margin of 9137 votes. He is a cabinet minister in the Hemant Soren government, holding the charge of rural development, rural works and Panchayati Raj departments Sita Soren

Born on February 21 1975, Sita Soren completed her Intermediate of Arts from DGSS Inter College under Jharkhand Academic Council in 2009.She was accused of receiving money from RK Agarwal in the 2012 RS polls as more than Rs 2 crore were seized from her residence.

Sita Soren's daughter Jayshree Soren also registered an FIR against Irfan under the SC/ST Atrocities Act for allegedly making derogatory remarks about her

Bomb in Indigo flight, proved hoax call, passenger arrested

A Kolkata bound indigo flight having 187 passengers on board was forced to make an emergency landing at the Raipur airport on Thursday morning after one of the passengers intimated the crew member about presence of live "bomb" on the aircraft, officials said.

After landing at the airport in capital city Raipur, the aeroplane was thoroughly checked by a joint security force team including CISF, Raipur police, bomb defusing squad, but nothing suspicious was found in the flight. After the bomb threat was found as a hoax call, police lodged a complaint against the passenger under the provisions of Aviation Act 1992 and by arresting him sent to jail.

The flight 6E-812, with 187 passengers and six crew members on board, landed at the Swami Vivekananda Airport in Raipur sometime after 9 am following the passenger's claim about the bomb in the plane Raipur SSP Santosh Singh told media.

After full sanitation the bomb in the flight concluded into a hoax call and finally police arrested the passenger, the SSP said. The accused was identified as Animesh Mandal, resident of Nagpur.
