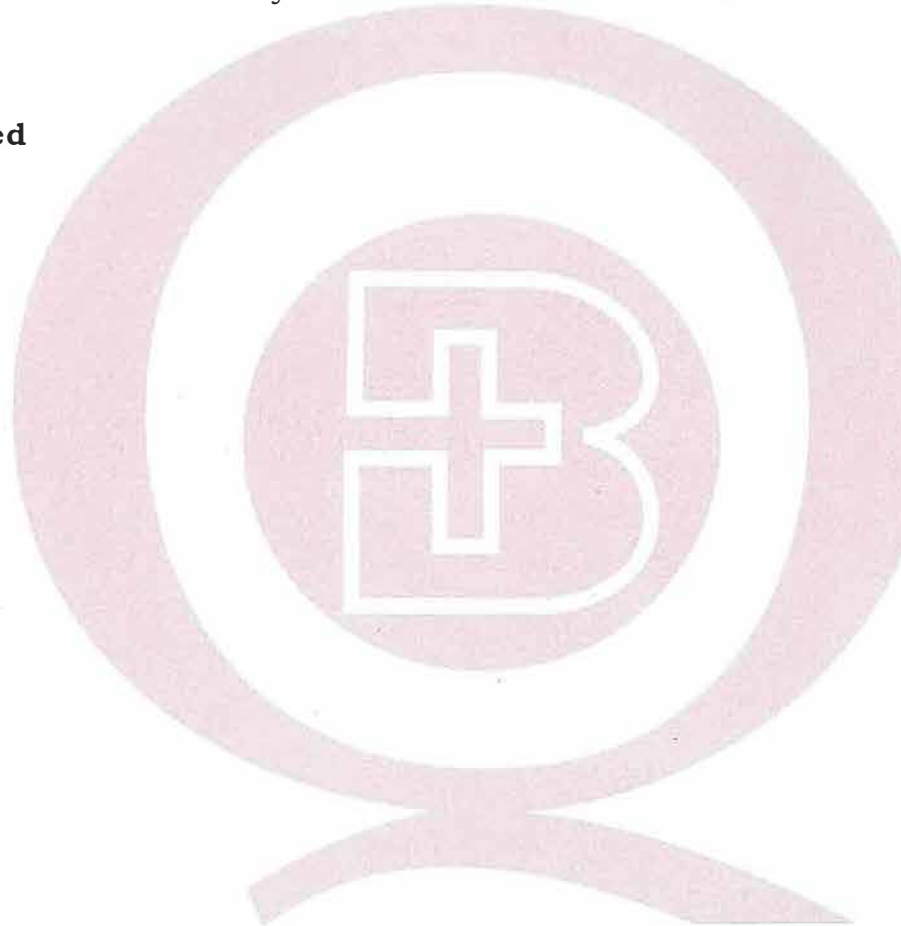

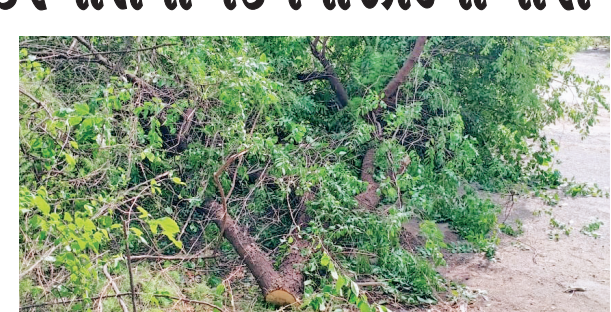

હતી અને મોટરસાઈકલને પાછળથી નિવુત બેક કમી મહેશ હરીભાઈ એક તરફ પડી ગયા હતા, જ્યારે વ પરિષ્વ માસૂમ બાળકી ધ્યાની રોડ તરફ પડતાં લકઝરી બસનું ટાયર ધ્યાનીના માથાના ભાગે ફળી વળ્યું હતું. ગોઝારી ઘટનાને પગલે માસૂમ ધ્યાનીનું સ્થળ પર જ કમકમાટીભર્યું મોત નીપજ્યું હોવાનું કહેવાય છે. ત્યારે બીજી તરફ દાદામાસા અને માતાને પણ શારીરિક નાની મોટી ઈજાઓ પહોંચી હતી. ઘટનાની જાણીને પગલે લોકો સ્થળ પર ભેગા થઈ ગયા હતા જેના પગલે લકઝરી બસ ચાલક સ્થળ પરથી ફરાર થઈ ગયો હતો. માસૂમ બાળકીના ગંભીર અકસ્માતને પગલે ઉરકરાયેલા લોકોએ લકઝરી બસના કાય તોડી ચક્કાજામ કરી દીધો હતો. ચક્કાજામના પગલે વાહનો અટવાતાં ટ્રાફિકજામના દ્રશ્યો સર્જાયા હતા અને લોકોએ તંત્ર વિરુદ્ધ ભારે સૂત્રોચ્ચાર કરી વિરોધ પણ નોંધાવ્યો હતો. ઘટનાની જાણ થતાં પોલીસ પણ સ્થળ પર દોડી આવી ચક્કાજામ કરનારોને સમજાવી સ્પીડ બ્રેકર અને સિગ્નલની માંગ સ્વીકાર્યા બાદ ટ્રાફિક હળવો કર્યો હતો. માસૂમ બાળકી ધ્યાનીના દેહને સિવલ હોસ્પિટલ પોસ્ટમોર્ટમ અર્થે લઈ જવામાં આવી હતી. ત્યારે અકસ્માતની જાણ થતાં સિવલ હોસ્પિટલમાં પરિજનો સહિતના લોકો પહોંચ્યા હતા અને માતા તેમજ પરિજનોના કાકલૂદી અને હેયાફાટ રુદનથી આસપાસ ઉભેલ લોકો તેમજ સિવલ હોસ્પિટલના સ્ટાફની આંખો પણ ભીની થઈ ગઈ હતી. ત્યારે ભરૂચવાસીઓએ પણ બિસ્માર રોડ રસ્તાઓ અને ગમખવાર અકસ્માતને પગલે તંત્ર પર ભારે ફિટકાર વરસાવી હતી.
