Nembers may note that the Board of Directors in their meeting held on May 25, 2023 has recommended a final dividend of INR 1.25 per share. The record date for the purposes of final dividend for the financial year 2022-23 will be August 10, 2023. The final dividend, once approved by the shareholders in the ensuing AGM will be paid on or before September 15, 2023, electronically through various online transfer modes to those members who have not updated their bank account details, dividend warrants/demand drafts/cheques will be sent out to their registered addresses once the postal facility is available. To avoid delay in receiving the dividend, members are requested to update their KYC with their depositories (where shares are held in dematerialized mode) and with the Company's Registrar and Share Transfer Agent (where shares are held in physical mode) to receive the dividend directly into their bank account on the payout date.
