### Sub: - Outcome of Board Meeting

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations"), we hereby inform you that a meeting of the Board of Directors of Ingersoll-Rand (India) Limited ("Company"), was held today, inter alia the following businesses were transacted

## 1. Resignation of Mr. Amar Kaul as Managing Director and his re-designation as the Non-Executive Director cum Chairman of the Board

Mr. Amar Kaul (DIN: 07574081) is taking up a global role within Ingersoll Rand group as Vice President and General Manager, ITS MEIA and Global High Pressure business effective October 15, 2021 and is relocating himself to Dubai, UAE. Consequently, he has expressed his desire to step down as Managing Director of the Company and offered to continue as Chairman of the Board. Based on the recommendations of the Nomination and Remuneration Committee and subject to approval the shareholders of the Company, the Board of Directors approved the resignation of Mr. Amar Kaul from the post of Managing Director effective close of business hours on October 14, 2021 and his consequent redesignation as the Non-Executive Director cum Chairman of the Board effective October 15, 2021.

# 2. Appointment of Mr. Inder Arora as Manager under Companies Act, 2013 (KMP)

Consequent to the re-designation of Mr. Amar Kaul as Non-Executive Director cum Chairman of the Board, the Company has decided to appoint a Manager as per the provisions of section 203 of the Companies Act, 2013. Based on the recommendations of the Nomination and Remuneration Committee and subject to approval the shareholders of the Company, the Board of Directors approved the appointment of Mr. Inder Arora, as Manager under the Companies Act, 2013 (KMP) for a period of 5 years commencing from October 15, 2021 up to October 14, 2026.
