


(CDSL) the authorized agency engaged by the Company to provide voting by electronic means and verification of data provided by M/s Purva Sharegistry India Private Limited, Registrar and Transfer Agent of the Company.

**I submit my report as under:**

1. In terms of Section 108 and Section 110 of Companies Act, 2013 read with rules and SEBI Listing Regulations, 2015, the Company had made arrangement with Central Depository Services (India) Limited (CDSL) for providing facility of voting through electronic means ("Remote e-voting") to its members.
2. In terms of applicable circulars physical ballots were not dispatched to shareholders, accordingly, the communication of the assent and dissent of the members had taken place through remote e-voting process and ballot sent through electronic mode.
3. As per Rule 20(4) and 22 (3) Companies (Management & Administration) Rules, 2014 the Company published an advertisement on 05<sup>th</sup> January, 2024 about the dispatch of Postal Ballot Notice in "Financial Express" (English Newspaper) and "Pratah Kal" (Marathi Regional Newspaper).
4. The members of the Company whose name were recorded in the Register of Members or in the Register of Beneficial owners maintained for it by the depositories (in case of share held in dematerialized form) as on the cut-off date i.e., **29<sup>th</sup> December, 2023** were entitled to avail the Remote e-voting facility, in respect of resolution set out in the Postal Ballot Notice.
5. In terms of Postal Ballot notice the Remote E-voting commenced on **Friday, 05<sup>th</sup> January, 2024** (09:00 A.M. IST) and ended on **Saturday, 03<sup>rd</sup> February, 2024** (05:00 P.M. IST).
6. All votes cast through e-voting during the abovementioned period, were considered for scrutiny and at the end of Remote e-voting period, the remote e-voting facility was blocked by with Central Depository Services (India) Limited (CDSL).
7. The votes casted through remote e-voting facility were thereafter unblocked in the presence of two witnesses who were not in the employment of the Company.
