Subject: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Please note that on December 27, 2023 at 3:12 p.m., the Company has received an Order from the Assistant Commissioner of GST & Central Excise, Nugambakkam Division, Chennai (“Authority”) for the period from July 2017 to March 2020, raising a GST demand of ₹6,435,178/-, interest of ₹1,578,829/- and levying penalty of ₹291,476/-.

The Company has already paid GST demand of ₹4,163,282/- and interest of ₹1,578,829/-. Accordingly, the Authority in the order has appropriated GST demand and interest to the extent already paid by the Company. Therefore, the net demand stated in the Order is ₹2,563,372/- (GST + Penalty) excluding interest on the net GST demand under Section 50 of the Central Goods and Services Tax Act, 2017.

The Company will be filing an appeal against the said Order.

The details of the said Order as required under Clause 20 of Para A of Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular dated July 13, 2023 is enclosed herewith as an **Annexure 1**.
